This has been designed to showcase how the UK's expertise in the technology sphere can support Turkey's post-Covid plans and its new 'New Economy Programme 2020-22'. It will also explore what the UK has to offer Turkish tech companies looking to grow their global presence by setting up in the UK.*

The UK Tech Week will bring together thought-leaders from business, government and universities, and host a series of exclusive keynotes, panel discussions, workshops and B2B meetings covering multiple sectors. These include renewables, digital health, medical technology, digital manufacturing, smart cities and UK-Turkey science and innovation collaboration. We expect to have an extensive range of UK companies participating through a virtual mission programme.

The 17 February has been designed specifically for Turkish tech companies looking to set up in the UK. DIT's Global Entrepreneurship Programme will hold a 'masterclass', which will provide advice on how to access to finance, pitch and fundraise in the UK market. There will be opportunities for one-to-one meetings with various experts and service providers throughout the day.
